APPOINTMENT OF ARBITRATOR UNDER SECTION 212(2) OF THE LAND CODE (*Cap. 81 (1958 Ed.)*)

In the matter of the extinguishment of Native Customary Rights over lands mentioned below and more particularly described in the Schedule attached hereto.

Whereas

(1) Under section 5(4) of the Land Code [*Cap. 81*] (hereinafter called "the said Code"), dissatisfaction with any decision on any of the grounds therein stated may be referred to arbitration in accordance with section 212 of the said Code; and

(2) Disputes and differences within the meaning of the said arbitration, more particularly on the amounts of compensation, have arisen between the Government of Sarawak and the claimants

Now therefore in pursuance of the power conferred upon me under section 212(2) of the said Code, I hereby appoint Saiful Bahri bin Adzmi to be an Arbitrator in the disputes referred to in the Schedule attached hereto.
